BACKGROUND:

Main Street Events LLC desires to hold several events downtown in 2023, in similar fashion to the First Friday's and other events held in 2022. Per the Town code, such events require a special entertainment permit issued by Town Council.

The First Friday's events will feature live music on the steps/walkway of Town Hall with select food vendors located as before—one on Town property and any others located on private property—and shops will be open. At this time, at least three markets are being planned, one in April, October, and December.

As before, minimal support is needed from the Town. Event organizers and vendors will ensure that all sidewalks and roadways remain unobstructed during the event, and will ensure the downtown area is cleaned up after each event. The list of proposed event dates and permit applications are attached for Council's consideration.

STAFF RECOMMENDATION:

Staff recommends Council issue a special entertainment permit to the downtown merchants for Gordonsville First Friday's and other events to be held, as presented.

Pursuant to Section 3-43 of the Gordonsville Town Code, staging, promoting or conducting any musical or entertainment festival in the town requires the issuance of a special entertainment permit by Town Council. Fire departments, rescue squads, agricultural fairs, service clubs, entertainment sponsored by local schools, or any event in which the participants are all school students are exempt from this requirement. Pursuant to Section 21-1 of the Town Code, occupation or use of the streets, sidewalks, parks, bridges or any other public places or public property or any public easement of any description in the town first requires consent of Town Council.
