



**TOWN OF GORDONSVILLE RESOLUTION

Resolution # 2016-5a**

WHEREAS, the Town of Gordonsville, Virginia is required by Chapter 25, Title 15.2 of the Code of Virginia, 1950, as amended, to prepare and approve a budget containing all contemplated expenditure of funds and to make appropriations therefrom; and

WHEREAS, the Town has prepared a budget for fiscal year beginning July 1, 2016 and ending June 30, 2017 as required by Section 9-3 of the Code of the Town of Gordonsville; and

WHEREAS, the Town Council, upon notice properly and duly given, held a public hearing on April 18, 2016 to receive public comment on the budget for fiscal year 2017; and

WHEREAS, the Town Council approved the budget, for fiscal year 2017 on May 16, 2016 as required and permitted in Section 15.2-2506 of the Virginia Code;

NOW, THEREFORE, BE IT RESOLVED by the Town Council for the Town of Gordonsville, Virginia, that Council does hereby make an annual appropriation in accordance with the attached schedule and contained in the approved budget for fiscal year 2016-2017 effective July 1, 2016.
